OUTLINE DESCRIPTION AND OBJECTIVES

This course outline seeks to develop a media law framework based on the Constitution, with a focus on human rights, human dignity, democracy, and sovereignty. Key concepts such as freedom of expression, the privileges and responsibilities of the press, media ownership and nationality, electoral regulations, and others are explored through this Constitutional framework. The outline also introduces areas of law that are of practical relevance to media workers, such as labor and intellectual property. At the end of this course, students are expected to have a holistic understanding of law and the Philippine legal system as citizens and media workers, able to competently engage with contemporary media law issues brought about by emerging technologies and socio-political developments.
